State Trooper Brian Kerrigan's Daughter Ciara arrived with something wrong. She failed to cry, wasn't breathing, and was limp. The delivery room immediately turned from a scene of happiness and joy, to a critical life threatening situation in the matter of seconds. Brian instinctively wanted to push the nurses aside and somehow breath life into her but he had to maintain his composure. From that day forward his life was forever changed and he vowed to protect her under any circumstance.

Genetic testing eventually revealed she had a very rare genetic disorder known as Prader-Willi Syndrome (PWS) characterized by severe hypotonia in infants, and excessive eating in early childhood gradually developing into morbid obesity. she currently takes thyroid medicine and growth hormones daily. Hudson County Corrections January 16th at 5 am Officer McCarthy's house caught fire. Due to his work schedule he was awake, and able to get his family out safely. His eldest daughter Brianna (16) called 911. John re-entered his home to retrieve his off-duty weapon so the ammunition would not cook off and hurt the firefighters. **All of his family's possessions were destroyed.** They were homeless for 4 months while rebuilding and returned home on April 28th.

NJ State Police Trooper Cullen while assisting at the scene of a vehicle fire was struck and killed by a passing vehicle near milepost 23 on the southbound lanes of I-295 in Deptford Township.

He was outside of his cruiser and walking near the scene of the fire when he was struck. Trooper Cullen was transported to Cooper University Hospital, in Camden, where he died from his injuries.

The driver of the vehicle remained at the scene.

Trooper Cullen had served with the New Jersey State Police for 18 months and was assigned to the Bellmawr Station. He had previously served with the Westampton Police Department. He is survived by his 9-month-old son and fiancée who was expecting another child.
