NJ State Trooper Marc K. Castellano lost his life in the line of duty while searching for a suspect on Route 195W near exit 31B in Howell Township when he was struck by a passing vehicle. He was rushed to a local hospital and later pronounced dead from the injuries he sustained on the morning of June 6, 2010.

His mother, **Donna Setaro**, is on a mission campaigning for more highway signs to bring public awareness to the **Move Over Law**, which safeguards first responders on highways and has made significant strides educating the public in order to prevent such tragedies from happening again.
